Time may be surrendered by deferring (1) one minute to another speaker, not to exceed a total of (8) eight minutes. The speaker wishing to defer time must be present when the item is heard. In order to be recognized and present an item, each speaker must complete and submit to the Recording Secretary a Request to Speak form prior to the beginning of the item being announced by the Chair (forms are available at the entrance to the meeting room). Speakers are taken in the order slips are submitted.

Items in Consent Calendar Section A have already been considered by the Commission at a previous meeting where the

public was invited to comment, after which a decision was made. These items are not subject to public discussion at this meeting because the vote taken at the previous meeting was final. Resolutions concerning decisions made at previous meetings are for the purpose of memorializing the decision to assure the accuracy of the findings, the prior vote, and any conditions imposed.

Subject: Parking Enforcement Service Level Review

RECOMMENDED ACTION: 1) Receive a report on the City's parking enforcement service level, and 2) Provide feedback and recommendations on any service level changes prior to a proposed contract renewal, if appropriate.

DISCUSSION: On July 3, 2024, the City's Parking Enforcement Team, courtesy of LAZ Parking, began operations to provide additional support to the Los Angeles County Sheriff's Department (LASD) and Volunteers on Patrol (VOP). Since starting in 2024, the Parking Enforcement Team has issued 59,322 citations for a variety of violations, including obstruction of roadways, obeying parking signs, blocking fire hydrants, oversized vehicle ordinance, unauthorized handicap parking, and more.

The Parking Enforcement Team works proactively to identify problem areas, inform vehicle owners of their violation(s) through warnings, and build relationships with the local community, all while working in partnership with LASD and VOPs. The Parking Enforcement Team has proved to be a significant asset in improving public safety throughout the City by decreasing the proliferation of RVs along Pacific Coast Highway, positively influencing parking behavior, and ensuring compliance with the California Vehicle Code and Municipal Code, as needed.

The City's Parking Enforcement Team currently consists of one (1) Parking Enforcement Supervisor, one (1) Parking Enforcement Lead, and three (3) full-time Parking Enforcement Officers that provide coverage throughout the day, including (1) Officer that provides overnight coverage on multiple days a week.

The current contract ends on June 30, 2026. To maintain continuity and excellence in service, staff is preparing a three-year contract renewal for City Council consideration. The proposed contract renewal would maintain existing staffing levels and provide flexibility for additional enforcement capabilities throughout the summer, primarily between Memorial Day and Labor Day weekend.

Staff is recommending that the Commission review current parking enforcement staffing levels and provide feedback and recommendations, if appropriate.

Subject: Homeless Services Monthly Report

RECOMMENDED ACTION: Discuss recent homeless services activities and receive and file the monthly reports for December 2025 from The People Concern.

DISCUSSION: Since 2017, the City of Malibu has provided homeless outreach services through a contract with The People Concern (TPC). TPC provides a three-person Outreach Team that engages people and families experiencing homelessness on the streets, hillsides, and beaches of Malibu. The team provides housing navigation services and individualized support to help them attain housing and become self-sufficient. The monthly reports summarizing their services for the month of December 2025 are attached.

December 2025 Report

Outcomes

In December 2025, the total number of contacts made by the outreach team was 197, with 59 unduplicated contacts 10 individuals were contacted in permanent or temporary housing. Of the 49 unduplicated contacts currently on the streets, 12 were new contacts, with 6 of them becoming repeat contacts. There are currently 22 contacts considered in various stages of engagement, and 27 are refusing services at this point. The outreach team continues to contact these individuals with the goal of getting them engaged in the housing process.

Success Story

In December, The People Concern's Malibu Outreach Team demonstrated the power of persistence, compassion, and collaboration through their work with SaBe, an elderly and medically vulnerable woman who was new to Malibu and living unsheltered. SaBe had only been in the area for a few months and was sleeping overnight beneath the courthouse for shelter. While she was initially not interested in housing services, the team continued to engage her consistently and respectfully—meeting her regularly at the Malibu CART lunch service, checking in on her well-being, and providing essential supplies such as hygiene kits, clothing, and water. This steady presence helped build trust, ensuring SaBe knew support was available when she was ready.

As December brought colder temperatures, SaBe began reaching out to the team to express concerns about her health and the impact of the cold. Although the team offered interim housing, she was hesitant due to the shared living environment that shelters often require—a completely understandable concern for someone navigating trauma and vulnerability. When weather forecasts warned of an incoming atmospheric river, with days of heavy rain and potential flash flooding, the team acted quickly. Recognizing the heightened risk to unsheltered individuals—especially elderly clients with health conditions—the team coordinated with partner agencies as LAHSA activated the Emergency Motel Voucher program. SaBe was immediately prioritized due to her age and health challenges. After being informed of the imminent storm and its dangers, she accepted an emergency motel placement. The team swiftly submitted the referral, provided transportation, and ensured she was safely sheltered from the extreme weather.

While SaBe was in the motel, the team continued their advocacy and supportive engagement, explaining that the emergency placement was temporary and discussing the benefits of interim housing as a safer, more stable option while awaiting permanent housing. After a few days, SaBe agreed to take this next step. The Malibu Outreach Team acted without delay—submitting interim housing referrals and collaborating closely with the Emergency Centralized Response Center (ECRC), which successfully matched her to a local interim housing site. The team provided transportation, assisted with the intake process, and offered emotional support throughout the transition. Today, SaBe is safely off the streets, in shelter, and having her needs met as she works toward permanent housing. Her journey is a testament to the Malibu Outreach Team's quick-to-respond efforts, strong interagency collaboration, and unwavering commitment to meeting clients where they are—especially when it matters most.

Next Steps:

The Malibu Outreach Team is looking ahead with optimism and momentum as we prepare for the upcoming Homeless Count. We are grateful for the continued partnership and collaboration with the City of Malibu, Los Angeles County, and our dedicated community volunteers, whose support is instrumental in ensuring that every individual experiencing homelessness in Malibu is seen, heard, and counted.

Our team is excited to come together with these partners to conduct a thorough and compassionate count, recognizing the importance of accurate data in advocating for resources, funding, and long-term solutions. We remain committed to ensuring that our community is not counted out, but rather fully represented, supported, and prioritized in the region's homelessness response system.

Subject: Parking Enforcement Monthly Report

DISCUSSION: On July 3, 2024, the LAZ Parking Enforcement Team began operations to provide additional support to the Los Angeles County Sheriff's Department and Volunteers on Patrol. Since the start of their operations, the LAZ Parking Enforcement Team has issued citations for a variety of violations, including obstruction of roadways, obeying parking signs, blocking fire hydrants, oversized vehicle ordinance, unauthorized handicap parking, and more.

The LAZ Parking Enforcement Team provides monthly reports that summarize their monthly citation counts and provides an overview of the most common parking violations. 


