

## Outreach Coordinator Weekly Update

**March 22 - 26**

### **Agoura Hills:**

OC engaged IND at the Park and Ride. IND has had a visit with his father who wants to split the price of a new vehicle. OC to inquire about a possible vehicle donation.

OC engaged IND at El Pollo Loco. IND, stated that he had a confrontation with his ex girlfriend who is also experiencing homelessness. She filed a complaint with the Sheriff. IND has court this week regarding the incident. OC to follow up.

OC and JT Manwell stopped to check a re-established encampment along the wall at California Edison. It is believed to be the same IND as before but nobody was at the site. OC updated Louis Celaya. OC left a message with Eric, who runs security at the facility. OC to follow up.

OC maintained daily contact with JT Manwell, Public Safety Liaison, throughout the week.

OC canvassed Twin Oaks and Agoura Meadows on a daily basis.



### **Calabasas:**

This IND will from here forward be referred to as C01.

OC and Deputy Mateo stopped at the Park and Ride to speak to C01 who is establishing a large encampment. He was not at the location. C01 is collecting a large amount of garbage. OC informed Michael McConville. Deputy Mateo stated that he is going to write IND a citation for littering.

Michael McConville stated that a 72 hr notice of cleanup will be posted tomorrow morning. The clean up will take place on Thursday. OC to attend.

OC received a request from the city regarding an individual at Gelson's who is playing music in the parking lot. OC spoke to the Assistant Store Manager who stated that IND had left the area. IND has not been seen at the location in several months.



OC attempted to locate C01 at the Park and Ride twice today. It appears that he has not returned to his camp since yesterday. The city will post a 72 hr clean up notice that will be executed Friday morning. OC to assist with the effort.

OC drove through the Park and Ride early this morning. It appears that C01 has brought additional items to the area. OC did not see him at the location, however, it was dark. A 72 hour notice was posted yesterday regarding a clean up effort to take place on Friday. It appears that the signage has been removed. OC to check the area this afternoon.

OC participated in the Calabasas Homeless Task Force Meeting. One of the items we discussed is attaching a number to individuals to differentiate between multiple individuals experiencing homelessness. Individuals will continue to remain anonymous in the weekly updates.

OC met with Deputy Mateo, Secur All and Public Works who cleaned up the encampment at the Park and Ride. C01 was not at the location or at the Gazebo on Calabasas Rd.



#### **Hidden Hills:**

OC checked in at Long Valley and Burbank Security Gates. Nothing to report this week.

#### **Malibu:**

OC engaged IND who stated that the inspection at his apartment has been completed. IND is waiting to meet his CM to go sign the lease. IND has made several attempts to contact his CM and has had no response. OC to follow up. This IND to be referred to as M01 here forward.

OC and Deputy Espinoza canvassed Legacy Park. OC engaged IND, male, 30s. IND was playing his music. IND stated that he would be sure to clean up.

OC was contacted by Tiffany S. from TPC regarding her client who has been matched to PRK. Tiffany asked if OC could help locating IND. OC located IND on Malibu Rd. and informed him that his CM was on her way to pick up. OC followed up with Tiffany who stated that everything went well with the transport.

OC transported 2 INDs to do laundry. OC set next laundry day appointment for the April 12<sup>th</sup>. Father Paul Elder., Homeless Advocate, offered to pay for the laundry services at that time.
